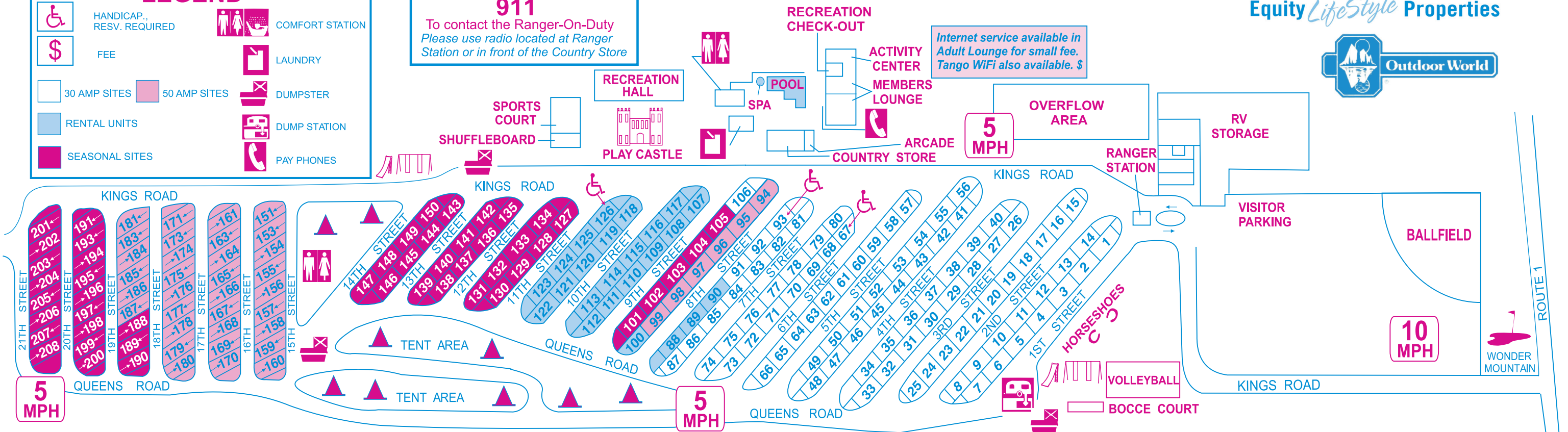

## COURTEOUS CAMPER

To make Outdoor World a fun place to be for you and your fellow members, there are a few rules for courteous camping which we have summarized below. Please refer to your member handbook for a more complete and detailed set of the rules which apply to the use of your membership.

**CHECK-IN:** Rental Units 4:00 pm • Campsites 12 noon

**CHECK-OUT:** Rental Units - 11:00 am

RV's, campers, tenters arriving 11 pm or later will be required to wait in overflow until after 7 am the next day to choose a site.

**QUIET TIME:** 11:00 pm to 7:00 am

Remember, sounds carry further after dark.

**COUNTRY STORE:** Hours are posted outside store.

**SPEED LIMIT:** 10 miles per hour.

Country store/ playground area: 5 mph.

Only people with a valid driver's license are permitted to operate a motor vehicle in the Campground.

**COMFORT STATIONS:** These facilities are cleaned daily, during which time they are not available for use. Please accompany a child under 6 years of age to the comfort stations. Please notify the Country Store of any situation needing attention.

**TRASH:** Please place all garbage in dumpsters. We do not have trash pick-up. Dumpsters are conveniently located around the campground. Locations are shown on this site map.

**CAMPsites:** Do not cut through other camper's sites.

**MESSAGES:** Non-emergency messages are posted on the message board located outside the Adult Lounge. Emergency messages will be delivered.

**CHILDREN:** All children must be on their site by 11 pm. Parents are responsible for what their children are doing at all times. Young children need to be supervised at the playground. **Children must be accompanied by an adult after 11 pm.**

**PETS:** All pets must be kept on a 10 ft. Leash, kept quiet and cleaned up after. Pets are not permitted in buildings, pavilions, pool and playground areas. Pet may not be left unattended. \$ in rentals.

**ALCOHOLIC BEVERAGES:** must be kept in a cup when carried off your site. Absolutely no excessive drinking.

**ROLLER BLADES & SKATE BOARDS** not permitted.

**BICYCLE** riding is not permitted after dark. Helmets are the law for children.

**MOTORCYCLES, MOPEDS & MINIBIKES:** Motorcycles may be driven to and from sites but not around the park. Mopeds, mini-bikes and motorized scooters are prohibited. Unregistered vehicles and off highway recreational vehicles are not allowed.

**CLOTHESLINES:** Absolutely no outside clotheslines.

**FIREARMS:** BOWS & ARROWS, SPARKLERS & FIREWORKS are not permitted.

**FIRE PRECAUTIONS:** A fire permit was issued by the town of Wells, ME on the condition that fires are kept low, always attended by an adult and confined to the existing approved fireplaces. Moving of rings is prohibited. A FIRE IS THE CAMPER'S BEST FRIEND AND WORST ENEMY. Extinguish your fire 100% with water before retiring or leaving your campsite.

**VEHICLES:** 2 vehicles per site. Other vehicles may be kept in visitor parking area. \$ (See Visitors)

**RV's** cannot be left unoccupied overnight. \$

**RV WASHING** is permitted in designated area. \$ permit required.

**WASHING** of cars is not permitted.

**CUTTING OF SHRUBS AND TREES** (including dead trees) is not permitted.

**VISITORS:** Members are limited to one guest family. Visitors must register and park in designated areas. If members are expecting visitors, they must be preregistered.

## POOL AREA:

- NO JUMPING
- Hours: 10 am - dusk. Pool closed when gate is locked.
- All children must be accompanied by an adult.
- No lifeguard on duty.
- Use pool and pool area at own risk.
- Swimming suits must be worn. No cut-offs or shirts.
- No running, diving or horseplay.
- No underwater equipment, tubes, floats, swimmies or water wings. **Only Coast Guard approved flotation devices allowed.**
- No glass bottles.
- Please keep the pool area clean.
- Pool furniture may not leave pool area.
- Observe all posted rules and signs in pool area.

**MANAGEMENT** reserves the right to interpret all rules to insure an orderly campground. Vandalism and shoplifting will be reported to the police. We reserve the right to ask a camper to leave for disregarding the rules. Please report any matter needing attention to the manager on duty.
